### Customer Profile

The Sunkist Country Club is one of the original golf courses opened in the Mississippi Gulf Coast. It opened in 1953 and is located very conveniently to all tourist attractions around Biloxi, Miss. It is also one of the most popular golf courses in the area. This beautiful manicured course is measured up to 6,400 yards with three sets of tees. The greens and course is maintained by excellent equipment to ensure the beauty and playing fields remain intact. They have been an LE customer since August 2003.

### Application

Scott Snell, maintenance manager, and Larry, his assistant, use Reelmaster 5400-D fairway mowers and other various equipment to keep the grounds maintained and looking beautiful.

### Challenge

The Reelmaster fairway mowers were running hot most of the time. They were looking to lower operating temperatures and to extend oil drain intervals.

### LE Solution

The local LE lubrication consultant recommended Monolec® Power Fluid (7500) and Monolec® GFS Engine Oil (8430). Monolec Power Fluid is formulated for combination hydraulic-gear systems, hydraulic transmissions and torque converters. It is nonfoaming in service and rejects water. Monolec 8430 is for heavy-duty service in diesel and gasoline engines. It exceeds
